Information on how to enter Herholdt's Group SolarEdge competition ("Competition") and prizes ("Prize") form part of these terms and conditions. By entering the Competition, participants ("Participants") agree to the terms and conditions as per the competition organizer ("Herholdt's Group").

The Competition opens on 01 August 2023 at 00:00 AM and closes on Wednesday, 31 July 2024 at 11:59 PM. Herholdt's Group will contact the winner by means of the contact details provided on 05 August 2024.

If Herholdt's Group are unable to contact a winner within seven (7) working days of first notification, the winner will forfeit the prizes and Herholdt's Group reserves the right to re-calculate a new winner under the same conditions of the Competition regulations.

1. How the FormulaSun Competition works:

- 1.1 The competition will be based on a point structure.
- 1.2 The Participant with the most points at the end of the Competition will be announced as the lucky winner.
- 1.3 For each SolarEdge product as set out below, the Participants will receive points added to the Participants name.
- 1.4 Herholdt's Group will calculate all points of the Participants at the end of each month.
- 1.5 A bar graph with the top three Participants will be shared on Herholdt's Group social media and Herholdt's Group website, every three months.

- 2.4 The Competition is open to citizens of the Republic of South Africa meeting the requirements set out in point 1, who are 18 years and older, except for the members, shareholders, directors, employees partner agents and consultants (and their respective life partners, business partners and immediate families) of Herholdt's Group.
